





**MEMORANDUM OF UNDERSTANDING
FOR ACADEMIC AND SCIENTIFIC COOPERATION**

Purpose:

The purpose of this Agreement is to promote cooperation in education and scientific research between the **Sardar Vallabhbhai Patel Arts & Science College Ainpur, Tal.- Raver, Dist.- Jalgaon, Maharashtra** and **TVES's Dhanaji Nana Mahavidyalaya, Faizpur, Tal.- Yawal, Dist.- Jalgaon, Maharashtra**.

Types of Cooperation:

Through this memorandum of Understanding, both Parties affirm the value of academic and educational collaboration and agree to promote the following activities:

1. Joint research projects in fields of mutual interests;
2. Exchange of academic publications and reports;
3. Opportunities for faculty and staff development and exchange;
4. Exchange of visiting research scholars, including advanced graduate students;
5. Other activities as mutually agreed.

This Agreement places no financial obligations or supplementary funding commitments on either Party. These activities will be defined through separate program agreements that detail the commitment of resources (financial or otherwise) required by each Institution. Subsequent program agreements must be approved in writing by the authorized representatives of each institution.

Principal, Dr. J. B. Anjane of the **Sardar Vallabhbhai Patel Arts & Science College Ainpur**, will serve as the primary liaison between the two institutions to facilitate the development of future activities.

Terms:

This Agreement will become effective upon the date of signature by both Parties. It shall remain valid for a period of three (3) years from the date of the last signature, with the



understanding that it may be modified by written mutual consent of both Parties. This Agreement may be terminated by either Party with advance written notice of at least thirty (30) days.

Upon notice of termination both **Sardar Vallabhbhai Patel Arts & Science College Ainpur, Tal.- Raver, Dist.- Jalgaon, Maharashtra** and **TVES's Dhanaji Nana Mahavidyalaya, Faizpur, Tal.- Yawal, Dist.- Jalgaon, Maharashtra** agree to work in good faith to enable visiting scholars to complete their respective research programs unhindered by the termination. The agreement may be extended by mutual consent of the two Parties after the three-year period, and it must be renewed in writing.

The parties to this **MOU** undertake to treat as **CONFIDENTIAL and PRIVILEGED** information of the other institution, which is so classified in advance. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.

This Memorandum of Understanding completed in English is hereby signed in two (2) copies with one (1) copy remaining in the possession of each institution.
