

## Eligibility Criteria for Admission to M.Sc. / M.A. as per norms of KBC North Maharashtra University, Jalgaon.

A Bachelor's Degree of minimum of 3 years duration or its equivalent (under the 10+2+3 or 10+2+2+1 year bridge course pattern of study Or any pattern fulfilling the mandatory requirement of 15 years formal education. Degree should be from a recognized University with a minimum of 40 % marks.

The Minimum requirement for admission to the M.Sc. M.A. degree programme of the Department of Social Work , NMU, Jalgaon is Bachelor's Degree in Arts, Science, Commerce, Law, Home Science or any other faculty of a recognized University with a minimum of 40% marks. Higher academic degrees or diplomas in Social Sciences and experience of working with people will be an additional qualification.

Candidates being deputed by Government or Private organizations should apply through proper channel with appropriate NOC. Direct applications shall not be considered.

### **Eligibility Criteria and Reservation Quota:**

All reservations given below shall be applicable to candidates belonging to Maharashtra state only subject to the fulfillment of the eligibility criterion specified by respective authorities from time to time.

#### **(a) Reservation for backward class category candidates:**

The percentage of seats reserved for candidates of backward class categories belonging to Maharashtra state is as given below. The percentage of reservation is the percentages of the seats available for Maharashtra candidates appearing for the entrance test, Backward class candidates shall mention the category to which they belong to at the time of submission of application form for Entrance Test.

#### **(b) Reservation for wards of defiance service personnel:**

Five percent (5%) seats out of total sanctioned intake capacity (50) of the department of social work each defense wing shall be reserved for wards of ex-service personal who are from Maharashtra.

#### **(c) Reservation for persons with disability candidates:**

Five percent (5%) seats of total sanctioned intake capacity of the department shall be reserved for candidates with disability.

The allotment of seats reserved for the candidates with disability shall be done on the basis of



merit. The candidates claiming reservation under this category shall here to submit the Physical Disability certificates issued by competent authority.

Note: -Candidates with disability should note that on admission to degree course they will not be given any exemptions or additional facility in the academic activities other than those which may be provided by the university.

(d) If the reservation quota remains vacant then 2% seats of total vacant reserved seats will be offered to SBC category.

(e) Reservation for EWS (Economical Weaker Section) Candidate: As per the provisions in Government Resolution No. राजाधो-4019/४.३.३१/१६-३, dated 12th February, 2019, 10% seats shall be reserved for EWS candidates. These seats shall be filled the Competent Authority through entrance test as per the policies of the Government declared from time to time.

(f) If sufficient candidates from Kavayitri Bahinabai Chaudhari North Maharashtra University area are not available for admission, candidates from other universities will be considered. Similarly, if candidates from other universities are not available for admission, the candidates from Kavayitri Bahinabai Chaudhari North Maharashtra University will be considered for admission. There will be separate merit list for other university students.

(g) Any change in terms of reservation from government side will be enforced with immediate.

#### **Distribution of Seats:-**

- a) 50% seats would be reserved for the candidates who have qualified from the Social Work discipline (BSW) in each of the above university area.
- b) Candidates graduated from KBC North Maharashtra University, Jalgaon: Home University 90 % seats
- c) Candidates graduated from other University (Other than KBC NMU.) 10 % seats

For all courses running in the School, seats will be reserved as per reservation rules and regulations of Government of Maharashtra and Kavayitri Bahinabai Chaudhari North Maharashtra University.

Sir,

I am directed to forward herewith a representation dated 05.05.2010 received from Sri Vivek Patil, Chairman, Manashri Shaikshanik and Krushi Sanatha, Nandubar, Maharashtra. The applicant has requested us to provide evidence that Gujar Community comes under linguistic minorities and their Gujar is a minority language within the Maharashtra State.

2. Language Profile of census 2001 reveals that there are 11284 Gujar language speakers in Maharashtra State. Linguistic Minorities are taken to be groups or collectivities of individuals, who speak an Indian language, which is other than the main official language (s) of the State/ UT concerned. The Gujar speaking people constitute linguistic minority group in the State of Maharashtra.

3. The State Government is, therefore, requested to extend all benefits to the Gujar community treating them as linguistic minority in Maharashtra. The action taken in the matter may kindly be intimated to the undersigned and the representationist.
